EXECUTIVE SUMMARY



The Montana Urban and Community Forestry Association (MUCFA) is a statewide, nonprofit organization dedicated to strengthening the health, resilience, and stewardship of Montana's urban and community forests. We work closely with our members, communities, and partners to promote best practices in urban and community forestry. We provide training and technical support, advance public education and volunteerism, foster collaboration across sectors, and help communities plan for and care for their trees according to industry standards.

In 2025, we strengthened our leadership role in supporting healthy community forests across the state. Through training, technical assistance, grant-funded projects, and workforce development planning, MUCFA supported communities of all sizes—especially small towns under 3500 population—while laying the groundwork for Montana's first urban forestry workforce program.

MONTANA TREE FAILURE DATABASE

MUCFA launched a Tree Failure Database—an open, statewide tool that helps arborists and communities learn from past tree failures to improve risk assessment and decision making.

GRANTS & FUNDING IMPACT

INFLATION REDUCTION ACT GRANT - DNRC

- \$40,000 awarded
- Completed a statewide urban forestry training needs assessment
 - 71 (50%+) of incorporated communities participated
 - 90+ urban forestry professionals participated
- 4 pilot trainings on pest and disease diagnosis planned
- Supported 4 communities with tree inventories in Chinook, Deer Lodge, Geraldine, and Wolf Point



FOREST ACTION PLAN GRANT -DNRC

- \$144,371 awarded
- Provided 9 communities with small grants. Grant outcome to date:
 - 2 tree inventories
 - 2 management plans underway
 - 6 hazard trees removed
 - 10 stumps removed
- Hosted educational booths at 4 conferences
- Completed 4 trainings



COMMUNITY TREE GRANTS -ARBOR DAY FOUNDATION

- \$38,000 awarded by Enterprise Mobility Foundation
- 64 trees planted
 - City of Missoula: 34 trees planted at Pleasant View Park
 - City of Hamilton: 30 trees planted downtown and at River View Park
- Volunteer engagement:
 - Enterprise Mobility Foundation employees
 - Trapper Creek Job Corps
 - Community and MUCFA members
- Funding for five years of maintenance to ensure tree survival

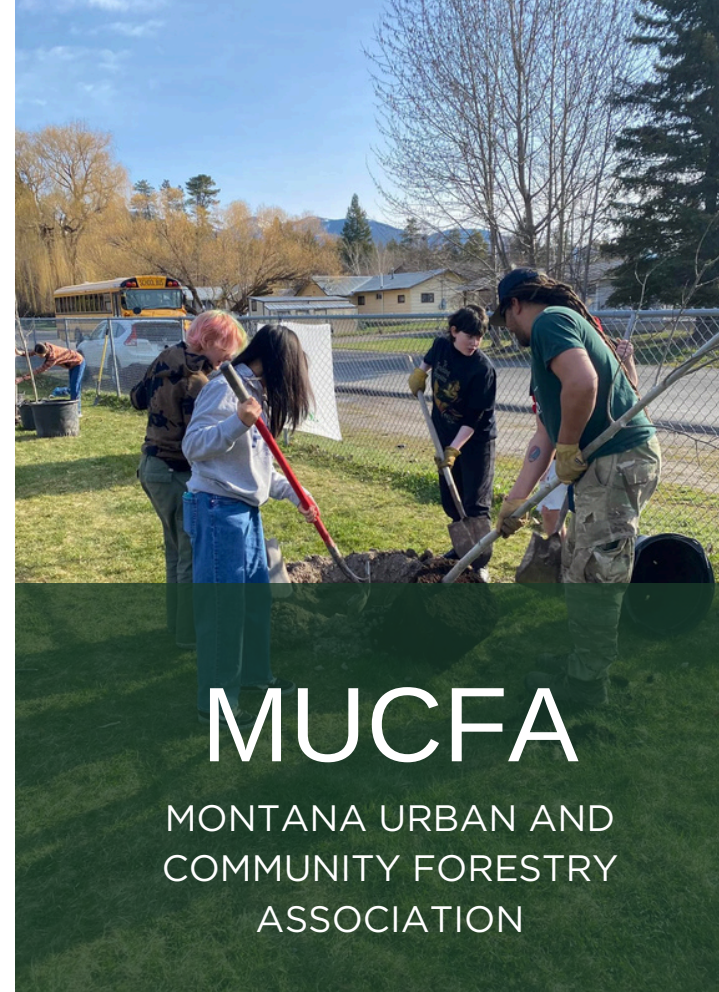
